BASIC SAFARI RATES INCLUDE

- ❖ Services of our fully qualified, licensed professional hunters
- ❖ Accommodations in safari camps or lodges during safari, depending on the area
- ❖ Full safari support staff as required
- ❖ Complete meals and all beverages (alcohol in moderation)
- ❖ Field preparation of all trophies
- ❖ Laundry service
- ❖ Value added tax (14%) on daily rate

NOT INCLUDED IN BASIC RATES

- ❖ Trophy fees on animals taken or wounded
- ❖ Costs of dipping, packing, crating and shipping charges for trophies
- ❖ Costs of air charters or transport as required or requested between hunting areas
- ❖ Costs of any required hotel accommodations before and after safari
- ❖ Extra bus/mini bus hire costs for big groups
- ❖ Telephone and fax costs
- ❖ CITES permit costs
- ❖ Gratuities for safari staff/professional hunters
- ❖ Rifles/shotguns can be hired from Infinite Africa at a cost of \$ 35 / day/rifle
- ❖ Ammunition is available at cost price / box opened.
- ❖ Airports pick up/drop off - \$180/per person min 2 (Johannesburg).
- ❖ Delivering of trophies to taxidermy

TERMS OF BUSINESS

- ❖ Rates quoted in \$ subject to change
- ❖ 50% of the daily rate of the trip is required to confirm a safari. The balance of the daily rate must be paid 90day prior arrival. For big 5 an additional 25% deposit of the trophy fee will be required. If the animal is not taken it will be refunded.
- ❖ A hunting contract, client information sheet and release of liability must be completed as soon as safari is confirmed via deposit
- ❖ Trophy fees are payable on completion of the safari.
- ❖ All fees are payable in U.S. Dollars, Euros & Pond sterling. Payments must be made in cash, traveller's checks or Credit card (5% fee).
- ❖ No deposit refund on cancellations less than 9 months prior to safari. You can however re booked with in twelve (12) months if cancelled. (once off)
- ❖ Certain species are subject to CITES quotas (*)
- ❖ Arriving day is seen as part of hunting days
